

If you are concerned about parking downtown, we urge you to consider taking the bus. For route and scheduling information, contact the Milwaukee County Transit System at 414-344-6711 (www.ridemcts.com) or the Wisconsin Coach Lines at 262-542-8861 (www.wisconsincoach.com).

Do NOT park at the meters on the street as you will be needed for longer than one hour.

However, there are some meters with extended hours south of E. St. Paul Ave.

The Federal Courthouse is open to the public at 8:00 a.m. You must enter through the main doors located on Wisconsin Avenue. The handicap entrance is located on the east side of the building at the Jackson Street entrance.

- All individuals entering the building are required to proceed through a security checkpoint. Any bags, purses, beverages, etc. will be examined through an x-ray machine. All electronic devices, wires and batteries need to be removed from cases and will be examined. No sharp metal objects such as knitting needles or finger nail clippers. You may be required to remove belts and shoes. Be cautious of what you bring and please be patient during the security process.
- A valid photo ID is recommended or sometimes required upon entering the building.
