**JOINT STIPULATION DISMISSING DEFENDANTS GOVERNOR EVERS,  
WISCONSIN DEPARTMENT OF ADMINISTRATION DIVISION OF GAMING, AND  
ADMINISTRATOR DILLETT WITHOUT PREJUDICE**

Pursuant to Fed. R. Civ. P. 41(a)(1)(A)(ii), plaintiffs the United States of America and the Commodity Futures Trading Commission and each of the defendants hereby stipulate and agree that the above-captioned action is voluntarily dismissed, without prejudice, against Anthony Evers in his official capacity as Governor of Wisconsin; the Wisconsin Department of Administration's Division of Gaming; and the Division of Gaming's Administrator, John Dillett. Each party agrees to bear its own costs in connection with this action.

This joint stipulation is made upon representation from counsel for the defendants that these defendants do not enforce the challenged statutes and that dismissal of these defendants will not affect the federal plaintiffs' ability to obtain relief to which they might otherwise be entitled in this litigation.
